Mr. Phenis stated that God created man and woman and that they should be separated. Mr. Phenis stated that the board should take a stand against this issue. Mr. Bowsman read aloud the email sent from the Department of Education and Justice on May 13, 2016. Mr. Bowsman stated that the school corporation received \$433,966 federal funding this year. The U.S. Department of Education and Justice provided examples of accommodations and policies being implemented throughout the country. Mr. Bowsman shared a few examples of those policies. Mr. Bowsman stated the safety and privacy of all students will be respected and ensured at Randolph Southern School Corporation. Mr. Bowsman reviewed Randolph Southern School Corporation's current policies and practices. Reasonable accommodations can be made, and have been made, for all individuals that necessitate additional privacy with the use of a nearby private restroom, shower or alternative schedule. To administration knowledge there have been no privacy issues from students or adults related to this issue.

Mr. Pat Allen stated that he appreciated forthrightness presented by the administration.
